ABOUT THE PROJECT

From 22-30 October. 2019 the TOT on Entrepreneurship Education will gather youth trainers and youth workers from Armenia, Czech Republic, Italy and Georgia to raise their capacity to plan and implement NFE programmes on youth entrepreneurship in a local or international context. During the TOT participants will practice card game on entrepreneurship -Entre-Train.

Training of Trainers on youth entrepreneurship education is part of long term project RECORD.

RECORD - "Raising entrepreneurial capacity of youth for rural development" is 2 years project, supported by Eastren Partnership Youth Window of Erasmus Plus programme. It aims to develop capacities of rural youth organisations of the Eastern Partnership region in entrepreneurship education (EE) using the local potentials of handicrafts and ecotourism. The project is led by a consortium of 4 organisations from the EU and the EaP regions- Youth Cooperation Centre of Dilijan NGO in Armenia (applicant and coordinator of the project), Civic Initiative in Georgia, Consorzio Leonardo in Italy and International Educational Centre GEMS from Czech Republic.

THE FOLLOWING TRAVEL LIMITS APPLY FOR EACH COUNTRY ITALY- 360 EURO PER PARTICIPANT, CZECH REPUBLIC - 360 EURO PER PARTICIPANT, GEORGIA-180 EURO PER PARTICIPANT

- Participants should organize their trip to/from the airport of their countries. These additional travel costs will be reimbursed if it will be within the Erasmus Plus distance limits (you need to keep for submitting all original tickets, receipt/invoices)
- IMPORTANT! Please keep all the boarding passes and send them to Youth Cooperation Center of Dilijan NGO. Boarding passes are the most important proof, which we need to keep for the report to EACEA.
- If you would like to have few days for exploring the country, it's possible to take 2 additional days before the arrival day or after the departure day. In this case, you would have to cover all the expenses connected with the additional staying (hotel, food etc) on your own.

It is possible to reach Dilijan through 3 airports:

- Yerevan International Airport (Armenia),
- Tbilisi International Airport (Georgia)
- Kutaisi Airport (Georgia).

The participants landing in Tbilisi/Yerevan on the arrival day will be picked up by the organizers. We will share with you more details afterwards!

VISA

Participants from European Union do not need visa to enter Armenia. However, all participants will need a valid international passport.

! Please, check the validity of the passports before the departure -its validity must exceed the validity of the requested visa by at least one month!



PARTICIPATION FEE

Each participant has to pay 20 euros participation fee during the training course.
